Meeting called to order @4pm Board of Health office Present: Nicholas Chiusano, Chair Elizabeth Massa, Clerk Bob Daley, Gene Waters, Norma MacDonald, Greg Harrison

BD Thanks NC and EM for running for BOH open seats in Chester Election

EM motion to have NC be Chair Voted Yes

NM asked if there are interested parties for third vacant seat

Health Agents; NC interviewed Lavigne, Lucas and Kaniecki. NC suggested Lucas and Kaniecki as BOH Health Agents, Lavigne would be alternate. Health Agents were all qualified and submitted resumes for covering, Title 5, food inspections, housing inspections. Health Agents desired rate of pay is \$60 per hour with 2 hour minimum. NM said Lucas has charged TOC travel time in the past. NC added Lavigne does not charge travel time. NC recommends all three Health Agents to BOS, request review by BOS of contracts and resumes. EM motion to have all three Health Agents be recommended to BOS to be TOC Health Agents Voted Yes

245 Route 20; Compliance of new septic. All permits completed and fees paid. NM asked who did the Title 5 inspection answered by NC was inspected by NC. EM motion to approve new septic Voted Yes

Cooper Hauling Permit; approved NM said installers permit was not approved previously by NM. Granted pumping permit by NM. NM asked to have EM ask BOS details of why. Notify Bruce Cooper his pumping permit and hauling permit is active. NC recommends Cooper to come to BOH office to discuss installers permit. EM to call Cooper and make appointment with NC. EM motion to approve Hauler/Pumper for Cooper Voted Yes

Public Comments; BD asked about Transfer Station attendant employment status. EM reported to BOS at July 15, 2019 meeting in Blandford that the decision was made to have Joan Stalcup, Terry Donovan and Anthony Turgeon as transfer station employees. NC said transfer station demo loads are limited to non commercial dump trailers. Transfer station fees need to be re-organized and enforced. All expressed vast improvements at transfer station including safety, cleanliness, ad organization. BD expressed that the BOH supervises the transfer station. EM stated the tires will be removed next week that have been thrown in the woods. Jersey barriers are still needed in front of demo and steel dumpsters, BOS was looking for availability apparently a shortage in town.

EM motion to adjourn, all in favor at 4:52
