Hampden, SS:

To any of the constables in the Town of Chester in the County of Hampden:

GREETINGS:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Chester qualified to vote in elections and town affairs to meet in the Chester Town Hall in said Town on Monday, September 24, 2018, A.D. at 6:30 p.m. in the evening, then and there to act on the following articles:

ARTICLE 1

To see if the Town will raise and appropriate the amount of \$6,400, or any other amount, to pay for the short term borrowing costs with regards to the borrowing for East River Rd., or to take any other action relative thereto. (monies not expended will go back into the general fund)

ARTICLE 2

To see if the town will vote to transfer from the Highway Salaries account the amount of \$8,000, or any other amount, into the Administrative assistant/Asst. Town Admin account to add to this account in order to hire a candidate at the hours/rate of pay, consistent with the market rate of this position, or to take any other action relative thereto.

ARTICLE 3

To see if the town will vote to rename the street "Town Road" to "Aldo's Way" ., or to take any other action relative thereto.

ARTICLE 4

To see if the Town will vote to authorize the Board of Selectmen to sell a 26 acre parcel of land shown on Assessors Map 401.0, Parcel 0001.0, to the Commonwealth of Massachusetts acting by and through its Department of Fish and Game for wildlife habitat and passive public recreation purposes, consistent with and subject to the purposes and protections of Article 97 of the Amendments of the Constitution of the Commonwealth of Massachusetts for the sum of \$25,000, or any other amount so deemed acceptable to the Board of Selectmen. The parcel is located off Skyline Trail and has been declared surplus property by the Board of Selectmen, or to take any other action relative thereto.

ARTICLE 5

To see if the town will vote to transfer the amount of \$2,500, or any other amount, from the COA Van Service line item to the COA Expense line item, or to take any other action relative thereto.

And you are directed to serve this warrant by posting attested copies at the usual place of posting warrants as per the vote of the Town (one at the Town Hall, one at the US Post Office, and one at the Chester Center) at least fourteen days before the time of holding said meeting.

Therefore, fail not and make due return of this warrant with your doings to the Town Clerk of said Town on or about the time of holding said meeting.
