New Business

-Review and vote on new Trash Haulers Permit Fee

Neighboring town fees for trash haulers are more comparable to \$150 a year, our current fee is \$75 a year. Trash haulers use our town roads, permits must be issued and reporting must be done. LW asked if BOH fees were being collected thru Permit Eyes. NC responded that the BOH has requested all BOH permitting to be done thru permit eyes, it has been requested to the BOS, we are waiting for it to happen.

Vote to increase Trash Haulers permit fee to \$150.00 per year. EM motion, NC 2nd, all voted yes.

-Review and vote on new Trash Hauler Rules and Regulations

Over the last few years many haulers have been doing business in Chester without a permit and not following regulations by the DEP despite the BOH actively tracking them down. Also, new, more strict trash hauler regulations regarding mandatory recycling have been put into effect last year by the DEP. The BOH would like to post these rules and regulations on the town website and actively pursue trash haulers to follow these regulations. Putting them on the town website and mailing them to known trash haulers may help them follow these regulations in town. By posting these regulations the town would qualify for more RDP grant monies as well. GH has been actively pursuing the trash haulers in town for the past year to be permitted. All trash haulers would need to be permitted by December 1st for the upcoming year. All trash haulers would be subject to recycling and reporting.

Vote to accept new Trash Hauler Rules and Regulations for the Town of Chester to be enforced by the BOH. EM motion, GH 2nd, all voted yes.
