Additionally, projects that provide benefits region-wide, including the Southern Hilltowns housing rehabilitation and septic repair program, and service programs including, but not limited to, Hilltown Social Services Program, Domestic Violence Prevention Services, Huntington Food Pantry, and the Southern Hilltowns Adult Education Center, will be reviewed for inclusion in the grant application.
