### New Business

#### -Discuss Transfer Station attendants and possible vote for hire.

Two open positions at the Transfer Station: Attendant and Alternate Attendant. BOH received two letters of interest, Ann Daley and Gregory Harrison. Both had experience working at the TS, have knowledge of recycling, DEP and rubbish regulations, eager to help the Town of Chester to keep the TS running smoothly and economically. Gregory is working a full-time job therefore filling in as alternate fits his schedule. Letter will be sent to the BOS giving our recommendations.

Vote to recommend Ann Daley as TS attendant and Gregory Harrison as TS alternate to the BOS for hire to the Town of Chester Transfer Station. NC motion, EM 2<sup>nd</sup>, all voted yes.

#### -Welcome new Board Member Duane Pease

Duane Pease was voted in as Board of Health for 2021, he is also the Town Administrator for Middlefield three days a week. He is experienced in working with the BOH in Middlefield and is glad to be a part of Chester BOH. The BOS is BOH, Jackie Duda was the health agent for years. EM hopes that he can help improve the Chester BOH and welcomes all suggestions to do more for the residents of Chester. DP also discussed the Berkshire coalition, public health nurse and what they can offer for \$2,600 per year. Middlefield pays \$5,000 a year for its health agent. MaryAnn asked if BOH would meet in person in the future in town hall and or Zoom. MaryAnn asked as Town Collector/Treasurer that the new TS attendant will be turn in the receipts by Thursdays at noon, agreed. EM encourages turning in all receipts immediately. Permit Fees for BOH are turned over as received as usual.
