

- -126 Middlefield Road Discuss and vote on status of septic as repair or new During the perc test Health Agent Kaniecki walked thru the building and observed no sanitary facilities. Terry Reynolds hired Dennis LaCourse for perc test and was only able to do soil sample because the water table was too high. Health Agent recommended limited use of the building. Anello asked the board if a composting toilet could be used, NC replied a composting toilet would only be allowed with a septic system and a "tite tank" requires a special permit. NC stated that a soil sample cannot be used for new construction of a septic system. Posey proposed sharing the existing septic at 133 Middlefield Road across the street and running the piping under the road, wants to directional drill under and then connect. EM asked Anello to email a copy of the Title V for #133. NC said sharing the system and piping under the road is acceptable. Anello asked if a variance could be considered by using the property next to #126, NC answered that the entire property would need to be purchased. Anello and Posey will go back to the engineer and study options to share the septic at #133 and pipe under Middlefield Road to connect at #126. No vote taken on repair.
- -146 Bromley Road Discuss and vote on three variances submitted by Barry Searle reviewed and read email from Searle. (attached)
 - 1. Distance from foundation from 10 to 8 feet NC stated tank will be on edge of property so bringing closer is acceptable.
 - 2. Two-foot separation to ground water for the Soil Absorption System NC stated it will not intrude into wetlands.
 - 3. Using a soil lab for a perc test rate NC allowed, because it is a repair.
