NOTICE TO BUSINESSES DBA'S

(doing business as) and SECOND HOME OWNERS

To All Individuals, Partnerships, Trusts and Corporations:

Mass General Laws Chapter 59 Section 29 requires that the Board of Assessors give notice to all persons subject to taxation in their respective town regarding personal property. Businesses must file State Tax Form 2. If you own a second home located in Chester, the furniture and fixtures are taxable, and owners must file annually, unless it's a rental property. Second Homes must file State Tax Form 2HF. If you have **already been** an established business or a second home, an application will be mailed to you. If not, Applications are available online at https://www.mass.gov/lists/property-tax-forms-and-guides, or at the Assessors Office. These lists must be filed on or before March 1st of each year. Failure to submit this list may remove certain rights of appeal for the taxpayer.
