Open meeting—This meeting was held at the Chester Town Hall, in the Auditorium with a virtual option.

Selectboard members present, John Baldasaro and Andy Sutton, Brian Forgue was on virtual. Town Hall staff present included Administrative Assistant Terry Donovan, Finance Committee member Andy Myers, Water Commissioners Bob Daley, Town Collector Mary Ann Pease, Highway Super Chip Dazelle, BOH members, Liz Massa, and Nick Chuisano and COA Directors, Kiersen Broman and Ann Daley and Fire Chief Henry Fristik.. Also attending Craig Gauthier, Pat Post, Elaine Gilmore, John and Wilma Foley, Bob Broga, Shelly and Rich Holzman, Ritchie Small, and Ellen Colson.

John opened the meeting after the Special Town Meeting at 6:20pm, warrants, minutes and all correspondence were signed.

Chip Dazelle Highway Superintendent update:

See notes attached. Rich Holzman approached Chip letting him know that the Sheriffs Dept . would come help clean the cemeteries and paint if time permits. Rich wants DPW to cart away brush. Brian Forgue also stated he spoke to Jessica Slatcher and Rich about this and thinks it's a good idea. Brian stated the DPW is adamant about not helping. Chip responded he would love to help but it needs to be a directive from The Town Admin or selectboard to do it and schedule it. He told Rich that and Rich said he would not talk to Don about it. John and Andy said a request like this needs to come to the selectboard so they can see if Chip can schedule it in. Chip cannot do special requests for everyone and needs to be scheduled.

Mary Ann Pease-Hilltown Community Ambulance

Budget has been signed. They have purchased a new vehicle, a 2011 FordX650 used, from NC. You will see it in use soon, will be Hilltown Ambulance colors of blue and white.

Co-Directors of COA progress report and Update on Code of Conflict

Ann said she has reached out to 65 COA Directors and is waiting for their feedback on a code of conflict. She said when it is done she will submit to legal for his feedback.

Keirsen summited one to Don last week but Ann didn't like that one. Keirsen said it had been a bad week in the COA, but that they did have a talk today and Keirsen wants to back down from what she is doing.



Ann wanted to know why the selectboard chose co-directors, John said because each showed good qualities, Ann the more clinical side and Keiresn the social side. And the residents want more social activities.
