Board of Health Meeting at Town Hall BOH Office Basement June 22nd, 2023 at 6:00 pm

Open Public Meeting at 6:05. Nicholas Chiusano, chair (NC), Duane Pease (DP), Elizabeth Massa (EM), Zoom: Elaine Gilmore

Agenda

-Approve last meeting minutes of April 21st, 2023. NC motion all approved.

-Review Transfer Station Bids. EM read bids. Dave Wickles Trucking was only bidder for hauling rubbish, demo and recycling. Changes are a two-year bid as opposed to three, a fuel charge in writing based on market prices. Board recommends Dave Wickles as hauler to BOS to be addressed and voted to sign at next BOS meeting. DP motion, all approved.

-Placement of Swap Shed and Timing. Agreed that we do not have to wait for millings to be placed at the transfer station before placing twenty-foot conex box for swap shed. Location to be to the right at the entrance of the transfer station next to fence. Swap Shed to be open Wed and Sat's for permit holders. Box to have 36" door cut in and painted one solid color. Box to be paid with RDP grant funding.

And any other concerns that can not wait for the next posted meeting

DP discussion on Hilltown Mobile Market by the Hilltown CDC and using town hall. Board agrees the following: Temporary Food Permit needed as well as Serv Safe and Mass Allergen certification, certificate of insurance, refrigeration equipment and serv safe manager on site. DP motion, all approved. Hilltown Mobile Market is permitted in Worthington, however that does not carry over to Chester. This was mentioned at a previous BOS meeting but no other follow up with the BOH. Was mentioned again at 06-20-23 BOS however still no contact from Hilltown CDC to BOH. Hilltown Mobile Market never contacted the BOH so the BOH will contact them via email to require the documentation. It is up to the TA about using the space in town hall.

DP asked about 2 Hampden Street trash outside and construction. EM has many complaints about this property and they have been sent to the enforcement officer/Building Inspector, EM to forwards emails to DP. Send out a letter to the homeowner also.

DP Clear rubbish bags. Black rubbish bags are to be phased out by July 1st. Clear rubbish bags lining black rubbish bags intentionally are not allowed.
