Rick Stone asked about the septic that is shared with the old bank. Veronica Mara asked about cost of upkeep.

Andy Myers recommended to suspend this article until the Annual Town Meeting in June.

recorded with the Hampden County Registry of Deeds in Book 1610, page 482, on such terms and conditions, and for such consideration, as the Board of Selectmen deems in the best interest of the Town; and further to authorize the Board of Selectmen to take any other action deemed appropriate in relation thereto; or take any other action relative thereto.

R Duane Pease suggested consulting a forester for the timber value and harvest the timber before selling to state.
