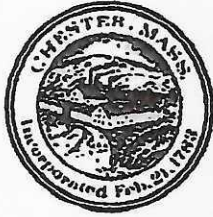
Don said he has found the old contract finally, it was misfiled. No time has been set yet with Comcast as to when they will meet.

Andy Sutton made a motion for a roll call vote to adjourn to executive session. 6:35


