John Baldasaro opened the meeting at 6:00pm. Warrants, minutes and all correspondence were signed.

Cornerstone Church discussion

Andy Sutton wants to put the vote on the next STM, not right to make the church wait for an answer. Johns feels it would not make good sense cost-wise for the town to accept it, he will refuse it. He feels the town cannot afford it, not fair to ask the town to support it.

Rich Holzman asked if the selectboard would think of other ideas, landmark building should not be just given away, would serve as a COA building and meeting house for the town, Police could expand into COA room, upgrade is not outrageous.

It was agreed to put it on the next STM.

Town Audit Review- Tony Roselli

Tony hit on a few points

- CMELD not included in audit is unusual,
- -RE taxes uncollected back to 1987, next to impossible to collect, should be cleaned up. Should have a plan in place to clean up yearly. Maryann said \$45000 outstanding has been cleaned up since the audit.
- -Should do a Security audit of IT dept, there is a grant for that offered now for that.
- -Tony mentioned to make sure ARPA money is obligated by end of the year
- -Should have policy and procedure manuals online
- -Overall, the financial health of the town is -Financially stable
- -Don will send Tony the CMELD audit when we receive it

- -Fire extinguishers at transfer station are all up to date
- -Hazard Mitigation meeting August 20 6:00pm at the Fire Station
- -Reported puddle in the building inspector's office

- Bob Daley gave a brief water update-Filter 1 is completely redone., it went online on Monday the 5th and is the only filter working right now. Filter 2 replacement started today 8/12, should be done by Friday. They drained filter 3 and added 18" of new sand to filter 3 today.

Meeting at noon on Tuesday 8/13 with DEP to hopefully rescind the boiling order, will share outcome with Don when meeting is over.

They need a written letter from Elm Electrical that the SCADA system is in compliance

-. Maryann Pease wanted to alert the Board about property in land court that is going before a judge on Thursday. That the town might need to evict. She has concerns about evicting someone that has been in tax title for several years, has made some payments but stills owes money. John said to discuss with Town council, there are new rules and options involved
